The Disability Royal Commission shone a light on what needs to happen at a law and policy level to ensure a more inclusive and just society for people with disabilities, including inclusive education. - Balancing the rights and needs of neurotypical and neurodiverse students

Session 2: Identifying And Managing Problematic and Harmful Student Sexual Behaviour

Problematic and harmful peer on peer sexual behaviour is becoming more common within the school environment and can manifest itself in a variety of ways, some of which can be difficult to identify. Session 4: Ransom Risks and Data Defences: Safeguarding Schools from Cyber Threats

Private schools are increasingly being targeted by cybercriminals who threaten to publish sensitive student and parent data unless ransoms are paid. As the Australian Signals Directorate recently warned, Australian education providers are now prime targets for extortion, underscoring the urgent need for schools to strengthen their cyber defences. This session equips schools with the tools and strategies necessary to combat these growing threats and protect their communities from devastating breaches. This session covers:

- Quishing, vishing and AI scams – the new cybercriminal techniques being adopted and how to spot them
- Integrating new technologies while maintaining privacy
- Strategies to prevent and mitigate cyber-attacks
- The anatomy of a good privacy policy
- Does a school's duty of care extend to avoiding acts or omissions that could cause harm to the privacy of staff and students?
