Session 4: Not All Scars Are Visible: Managing Psychological Injury and Return to Work in the NFP and Charities Sector

Working in the charitable and not-for-profit sector can involve high levels of emotional engagement and interaction with vulnerable populations, which may expose employees to psychological injury. As a result, organizations must be equipped to effectively support employees who experience mental health challenges while ensuring legal compliance throughout their return-to-work process.
