### Session 2: Go Directly to Jail, do not Pass Go: Cartel and Monopoly Law for Australian Agribusinesses

While cartel activity has been illegal for some time, the additional sanctions of criminal conviction for cartel conduct has resulted in a renewed focus by the ACCC to ensure all Australian businesses are incentivised to get compliant. For the agribusiness sector, the recent proposed reforms to mergers and acquisitions means it is not only harder than ever for agribusiness to do a deal but they are at an increased risk of falling foul of cartel and monopoly laws if they do. To help agribusinesses steer clear of claims of cartel activity, this session will explore:

- Types of cartel conduct, examples from successful prosecutions, and insights into the potential and actual penalties in such cases
- Recent trends emerging of inadvertent cartels arising through development of environmentally sustainable projects, and tips for avoiding this
- In what circumstances may cartel conduct cross over into a criminal prosecution and the difference between the two approaches in terms of the impact on the business and directors

Session 3: Going beyond the Board: ESG Compliance And Sustainability From A Whole Of Business Perspective

These days, ESG compliance is not just a matter for the Board. Instead, it should serve as the driving force behind a comprehensive business strategy, actively guiding operational decisions across all echelons of the organization. The consequences for businesses who fail to discharge their ESG obligations extend far beyond the significant penalties and legal ramifications for directors and owners. They also include damage to reputation and restricted access to foreign markets and with the recent creation of a new sustainability ACCC taskforce, the risk of getting caught up in an inadvertent breach has never been higher. To help agribusinesses stay on the right side of the law, this session will explore:

- The ESG obligations agribusinesses face and the wide range of factors it can actually encompass - from their environmental position through to their approach to diversity and inclusion in its workforce, gender pay gap issues
- The reporting obligations for different agribusinesses (including for modern slavery), systems required to gather the data required for reporting, the pros and cons of voluntary reporting and an update on the introduction of mandatory reporting
- The benefits to a business from ESG compliance and the consequences for the business, Board, directors etc if they fail to comply, including impact on access to specific foreign trade markets
- How to look at ESG from a whole of business perspective using some practical examples of businesses which have done this well

Session 4: Biosecurity Threats and the Lumpy Skin Disease Scare: Lessons Learnt from the Benefit of Hindsight

In 2023, the Australian live beef export trade suddenly ground to a halt when the Indonesian government announced there had been an outbreak of lumpy skin disease on cattle imported from Australia. The sudden decision left the industry reeling, leaving many wanting to know more about the process and their rights, obligations and options in the wake of an unexpected turn of events. Using the lumpy skin disease scare as a case study, this session explores the key biosecurity risks for agribusiness and how they can be best mitigated, including:

- The key laws and regulatory scheme governing biosecurity requirements and systems
- What happens when an outbreak is discovered, including the role of government, options available for the producers, and recovering losses
- Spotlight on practical farm impacts from an outbreak, loss of land value, breach and/or loss of contracts
- When will personal and/or company civil or criminal liability arise?
- What lessons can be taken away from the lumpy skin disease scare and can such an outcome be prevented in the future?

### Session 9: Safety Doesn't Happen By Accident: Workplace Health And Safety For Agribusinesses

The agricultural sector is one of the most dangerous sectors in terms of physical injuries and fatalities in the workplace. In recent years, there has been a wave of reforms to occupational health and safety laws in many Australian jurisdictions which have significantly increased liability for directors of employing authorities. In some jurisdictions, these workplace health and safety changes even result in directors being held criminally responsible for a failure of the business to comply. This session shall help agricultural business get up to speed on their obligations and steps they can (and are expected) to take to minimise harm in their workplace. It covers:

- WHS obligations for agricultural business around Australia, discussing issues that have arisen in practice
- The more significant aspects of new legislation, including criminal responsibility for directors, what is required for a prosecution and how the courts have responded to the new WHS laws
- WHS requirements of specific industries (including the transport and logistic industry) and the chain of responsibility and practical tips for business to create safe workplaces
