Session 1: From Duty to Liability: Directors' Duties and Risks in Agribusiness

These days, directors are subject to an ever-increasing raft of duties, spanning every aspect of business and enterprise operations. Directors who fail to discharge their duties not only run the risk of being held personally liable for civil penalties, compensation, debts and financial losses but may now even face imprisonment for particular breaches. This session will provide agribusinesses with a clear understanding of key liability risks facing directors in agribusiness and provide practical strategies for supporting directors in maintaining compliance across a diverse set of obligations. It covers:

- **Spotlight on WHS compliance:**
 - Review of directors' responsibilities in maintaining WHS standards, focusing on the agriculture sector's high-risk areas, including machinery safety, chemical handling and seasonal workforce management
- **Environmental and land use compliance:**
 - Potential liabilities related to land and resource use, including regulations on soil and water quality, management of natural resources and penalties for unauthorised land clearing or environmental damage
- **Supply chain transparency and modern slavery compliance:**
 - When is due diligence inadequate and what steps should be taken if violations occur within supply networks?
- **Responding to breaches - an in-house counsel's role:**
 - What in-house counsel should do if a breach occurs, from notifications and compliance assessments to managing board and public relations
 - Explore the support in-house counsel can offer to directors, including risk mitigation strategies, crisis management, and remediation measures.

Session 3: Preparing for Nature Positive: The Road Ahead for Agribusinesses

Since 2022, there has been growing momentum in both Federal and State environmental regulation legislation towards the concept of 'nature positive'. Stage 3 of the federal reforms will see a wholesale restructure of the environmental legislation to achieve nature positive outcomes. With further (significant) changes on the way, now is the perfect time to pause, take stock and reflect on the concept and what a move to 'nature positive' will mean for agribusinesses and what steps should be taken now to prepare for the changes. This session examines how the move to nature positive will impact the sector, as well as specific business strategies, including:

- Deep dive into the reforms, focusing on how they change the obligations for, and impact, individual agribusinesses
- Practical ways in which it is anticipated businesses from a range of agricultural industries could move away from ecologically sustainable development towards achieving 'a net gain for nature' - what are some examples of projects which modified or supplemented existing business to be nature positive, what was required to produce net gains etc
- How the AMO (avoid, minimise and offset) hierarchy will be incorporated into the legislative framework, the role of the offsets regime in the new framework and share, in a practical sense, what may satisfy reasonable measures, reasonable steps, genuine measures etc given the lack of definition in the amendment bill

Session 5: Change is A-coming: How Australia's Merger Law Regime will be overhauled in 2026

Australia's merger law regime is set to be overhauled with the most significant reforms to M&A in 50 years set to come into effect in 2026. Apart from the move from voluntary to mandatory notification requirements and need for ACCC approval for certain deals (that meet new thresholds), there are key aspects to the new merger law regime that will impact agribusinesses including fixed review periods, increased decision-making powers for ACCC, new tests for assessing an acquisition's effect on competition and a substantial public benefit test. This session will help businesses understand these changes in detail and will explore the steps required to increase compliance with the new merger law regime, including:

- The current proposal for the thresholds (monetary and market concentration) and special rules for serial acquisitions that will trigger the need to obtain ACCC approval and notify
- What will constitute a material connection to Australia and provide examples of new transactions that may be (surprisingly) caught by the new regime
- How the thresholds are anticipated to be applied in practice by the ACCC
- The new fixed periods in the merger review process and share tips for inhouse counsel to manage internal compliance with the new timelines
- How the ACCC is anticipated to apply the new competition test and substantial public benefits test, flag issues which may arise for individual businesses
- Deep dive into the increased administrative decision-making powers of the ACCC with a focus on what this will mean for agri-businesses (e.g. process to review ACCC determinations, tips for applying and preparing for review, and the Notice of Competition Concerns for acquisitions subject to phase 2 review)

Session 6: Fair Play in Agribusiness: Safeguarding Against Anti-Competitive Risks

As penalties for competition and consumer law breaches continue to rise, agribusinesses must be vigilant in preventing anti-competitive practices. This session provides essential guidance on identifying, mitigating, and managing risks related to anti-competitive behaviour. Key topics include:

- Responding to regulatory inquiries – practical advice on responding to inquiries and investigations.

It has been 2 years since the ACCC published its report on the greenwashing by businesses in Australia. Since then, corporate regulators have continued to crack down on businesses engaging in purported greenwashing with several high-profile Federal Court wins. But is this current focus in the environmental space a sign of more to come? To help understand the priority of the regulator when it comes to greenwashing and environmental concerns, this session shall:

- Examine whether the 2023 report and subsequent cases have resulted in any change by businesses from the perspective of ACCC
- Share insights from the regulator about problematic behaviour in the agricultural space involving greenwashing - what behaviour in the agricultural space they are seeking to target

- Examine recent significant Federal Court decisions involving greenwashing

Session 9: Agriculture 4.0 - Being Cyber Safe in Smart Agriculture

Smart farming is here and looks like it is here to stay. It seems that almost every aspect of the supply chain has been digitised and automated - from farm, machine and distribution level. While this has brought significant benefits, increased digitisation and automation has also exponentially increased opportunities for cyber-attacks. Agricultural enterprises are particularly vulnerable given the speed at which the sector adopted innovative smart farming technology and infrastructures. As a result, Australian agribusinesses are becoming an increasingly attractive (and lucrative) target for cyber-attacks. To help the sector comprehensively understand the cyber-security risks - and how such risks could be mitigated against - this session examines the following:

- Current trends in cyber-threats to all levels of the smart farming technology architecture from around the globe, including sensing layer, network/data communication, support and application layers, and smart farming infrastructure levels
- Current best practice for how the agricultural sector could/should respond to cyber threat intelligence, including the role of Chief Information Security Officer and related governance frameworks

Session 12: PPSR: Making It Work for You

Does your agribusiness buy or sell livestock, wool, timber, harvested produce, feed, fertiliser, crops or nursery trees? Does it lease, bail or hire out stud, breeding stock or sell or lease farm machinery or irrigation? Does it sell grain or other goods on credit or retention of title terms? If the answer to any of these questions is yes - then you need to have a sophisticated understanding of the PPSR. This session explores the key issues, including:

- Some of the practical issues and challenges of seeking security over livestock (e.g. registering livestock - tracing of livestock through NLIS etc)
- The use of the PPSR as a risk management tool
